 - Not establishing policy;
 just maintaining status
 quo
 - Won't impact spending by itself

- Reflected in 2013 tax bills issued next July

Princeton Open Space Tax

- 'Broad Form' ordinance authorizes many uses:
 - Acquisition, development & maintenance of lands for recreation & conservation purposes
 - Farmland acquisition & preservation
 - Historic preservation
 - Payment of debt service incurred for authorized purposes
- Both Boro & Twp spend more on authorized uses than they collect in OS Tax
