A message from the Chairman

The Village of Seneca Falls Dissolution Study Committee was authorized in October 2008 by vote of the Village Board of Trustees. It includes both town and village members. The Committee’s purpose is to study alternatives and prepare a plan for dissolution of the village as required by New York State Village Law Article 19. The process has begun. Five subcommittees are working to understand what is and what could be in order to make reasonable recommendations which best serve residents and reduce taxes. Our draft plan will be presented for public comment in September of this year. Following review and amendment, the Final Dissolution Plan will be presented to the Seneca Falls Village Board on December 7, 2009

The Board has pledged to put the plan to a vote of the village residents in March of 2010.

This Committee can only make recommendations regarding police protection, street maintenance, trash pickup, historic preservation, water supply, fire security, sewer, sidewalks, cemetery management, and many other services currently provided by the village.
